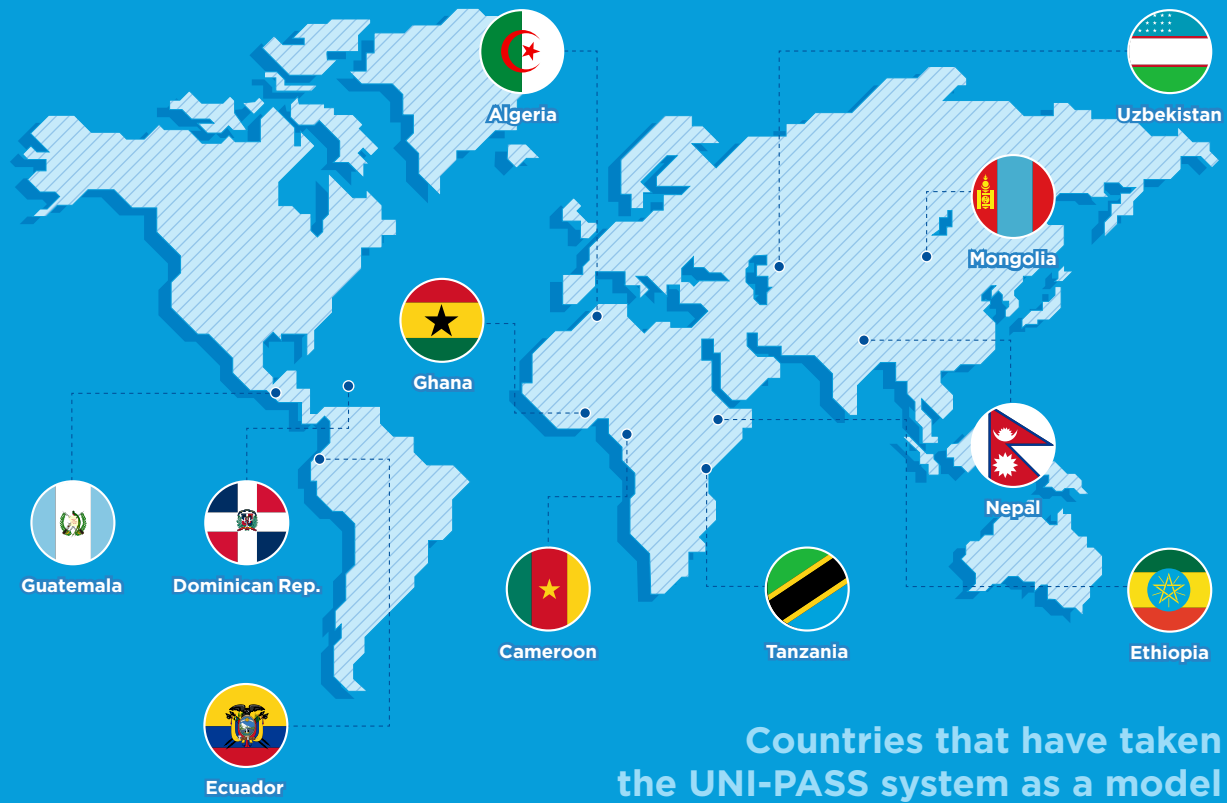

ECUADOR

Customs & Single Window System (2011 ~ 2013)

Named after UNI-PASS, the Ecuadorian customs system ECUAPASS won the WCO innovation Award at the TI forum in 2013 (Argentina). The development resulted in decreased clearance time and increased revenue.



TANZANIA

Customs System (2011 ~ 2014)

According to the Self-evaluation performed by the Tanzania Revenue Authority, the developed customs system, TANCIS, has raised user friendliness while import clearance time was reduced to 3.12 hours.



UZBEKISTAN

Single Window System (2014 ~ 2016)

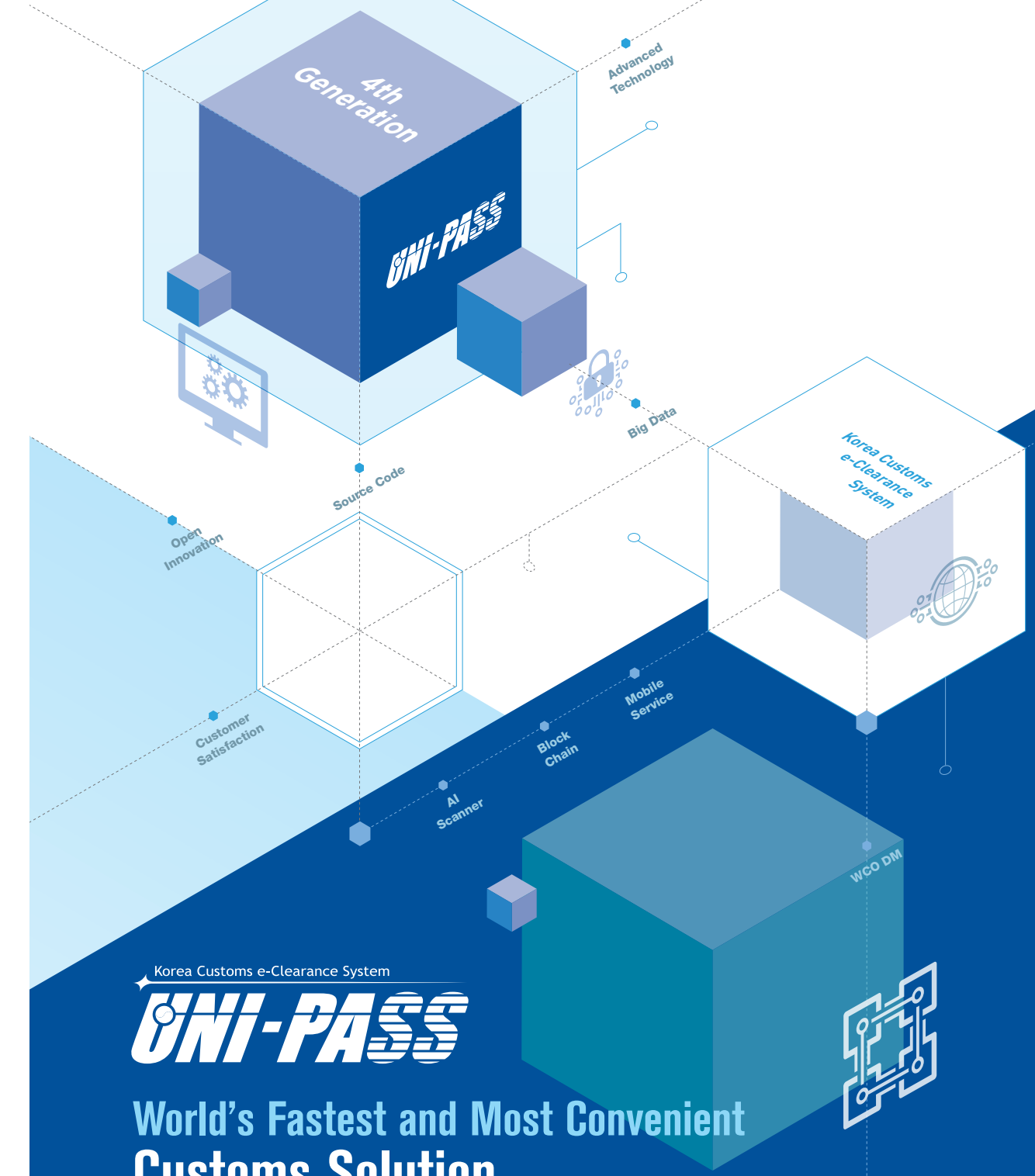
Interconnecting the newly developed Single Window system with the existing customs automation system, the system promoted the receipt of applications subjected to mandatory regulation for export and import trade operation.

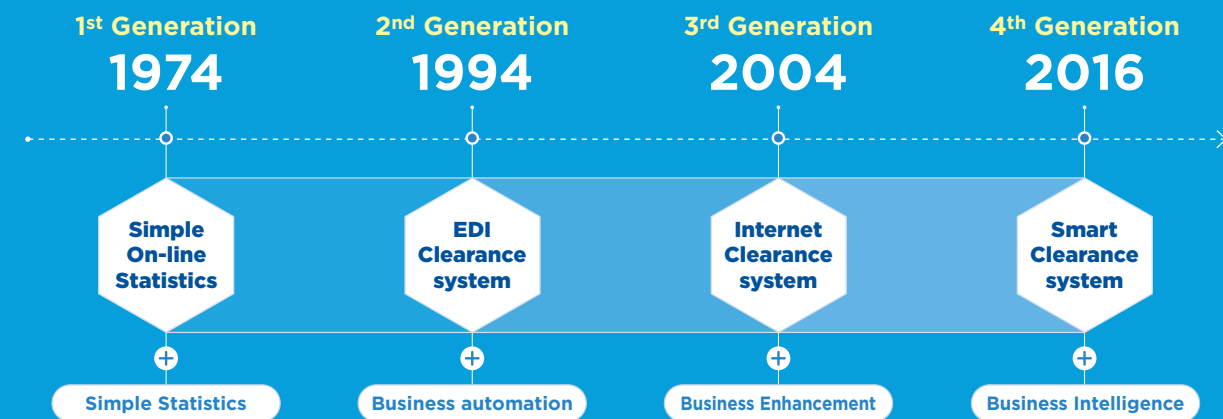

UNI-PASS at a glance

What is UNI-PASS?



UNI-PASS is a system developed by the Korea Customs Service for swift clearance, accurate duty collection, high national security, and control of illegal trade. Since its introduction in 1974, UNI-PASS has gone through drastic innovation aiming to be the best clearance system in the world. It is still under the strides of reformation and modernization embedding the know-how and technology from the past 45 years. Several customers noticed its' excellency and it was implemented in full automation or separate modules to meet the needs of the local environment.



What Services are Provided with the UNI-PASS System?

Consulting (F/S·Master Plan·BPR/ISP)

Customized consulting services create road maps for customs modernization. This includes improvements in the area of customs laws, customs business, customs system, standardization, integration and optimization of the customs administration.

Operation & Maintenance

Operation and maintenance service is provided post-development to ensure the system delivers a 24/7 seamless service to the public. Security measures are applied to monitor and prevent non-authorized access to the system.

Development (Partial·Full·Customized)

The customer is provided with a fully tailored customs solution suited for the local environment including project management and a full training and knowledge transfer program. UNI-PASS also provides system source code.

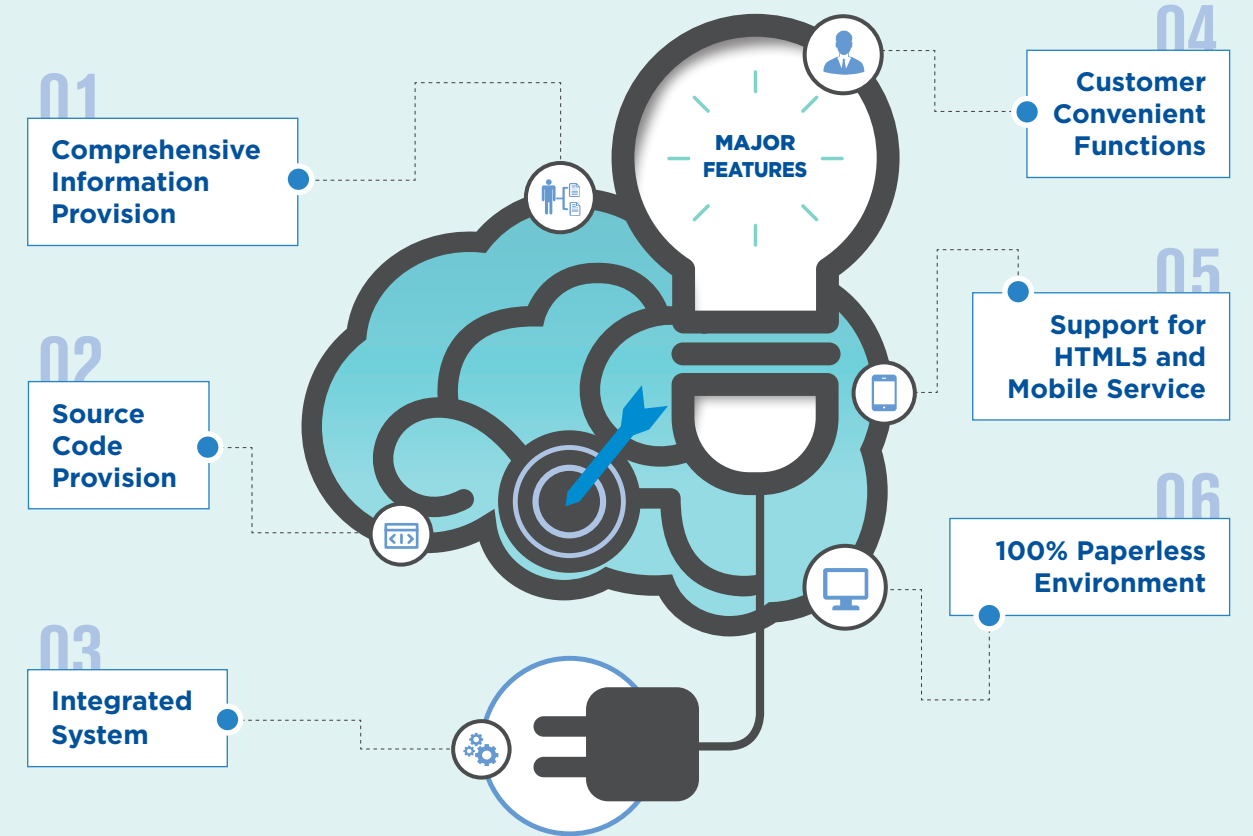
Financial Support

UNI-PASS Key Modules



Major Features



01	Comprehensive Information Provision	The portal provides comprehensive information for the convenience of the internal and external users. Consultative information such as customs laws, HS, guidelines for import and export, information search, and LPCO requirements based on HS are provided.
02	Source Code Provision	UNI-PASS provides all the source codes of its solution to the clients. If the client desires, a full training and knowledge transfer is provided so the client can operate and maintain the system independently without the need to receive support from a third-party.
03	Integrated System	UNI-PASS is a customer oriented system that provides all customs services in a single platform. From declaration to the release of the cargo, the system entirely handles every procedures and supports easy trading environment.
04	User Convenient Functions	Filing declarations have been improved to minimize data input and allow for reuse of information already available in the system. Moreover, internal users will benefit from personalized services such as my personalized menu's and search capabilities to aid them in their daily work.
05	Support for HTML5 and Mobile Service	The system supports HTML 5 through browsers such as IE, Firefox, Chrome and Safari through various OS (Windows, Linux, Mac OS). Also, if the client desires, mobile access to the system can be supported.
06	100% Paperless Environment	UNI-PASS is based on a 100% paperless environment from e-declarations to the capability of uploading supporting documents in electronic form. This allows a 24 hour clearance service without the need to physically visit customs to declare or the banks to pay.
